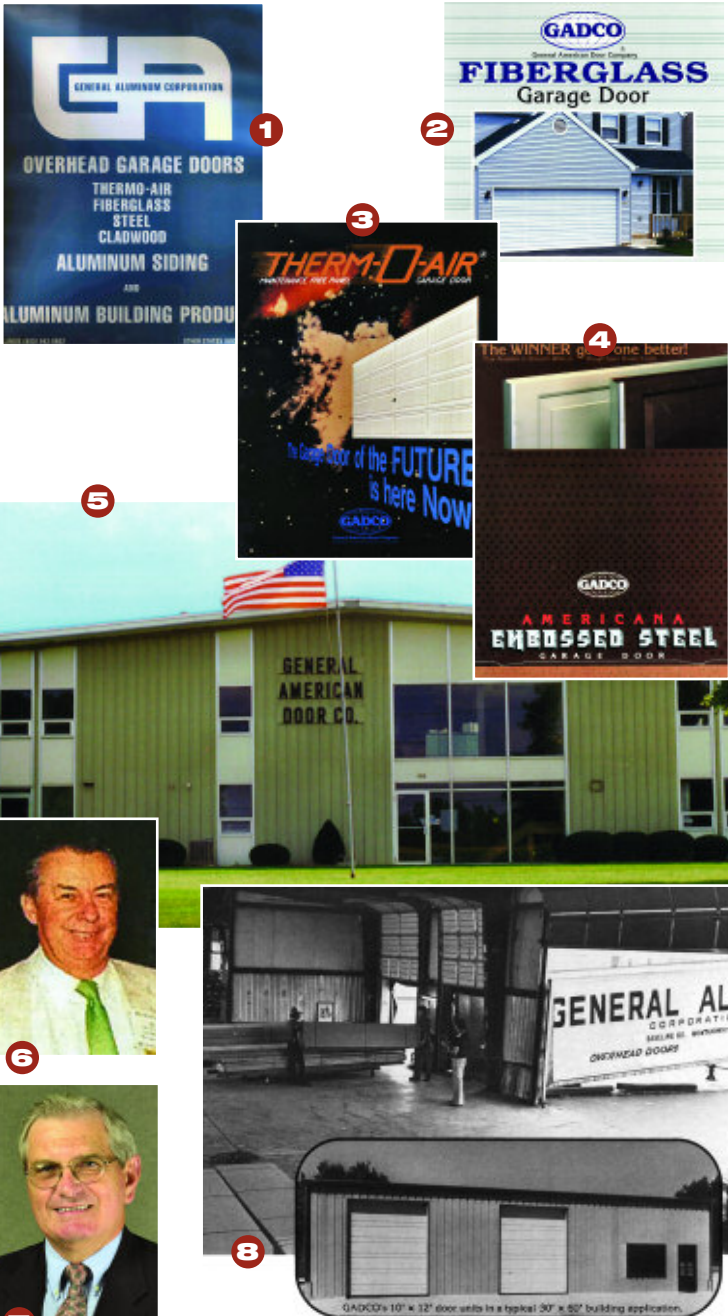


FROM THE PAGES OF HISTORY

General American Door Company

Editor's Note: In 2005, GADCO celebrates its 40th year in the garage door business. Here's a look back at its beginnings and key milestones.

Milestones

- 1961 Louis Vago and Paul Kleinwachter establish General Aluminum Corporation, providing residential aluminum siding to meet a growing trend in America.
- 1964 The company's new manufacturing plant in North Aurora, Ill., begins producing aluminum siding, selling its product primarily through lumberyards in the Midwest.
- 1965 Capturing another growing trend, the firm expands manufacturing operations to produce fiberglass garage doors, marking its beginnings in the garage door business. The doors, like the aluminum siding, are sold primarily through Midwestern lumberyards.
- 1971 The company moves to its current location in Montgomery, Ill. After five expansions, production space grows to more than 175,000 sq. ft.
- 1974 The firm invents and patents Therm-O-Air, the industry's first high-density polyethylene (HDPE) door in an all-aluminum framework.
- 1979 The Liberty, the company's first steel garage door, is introduced. The door is a ribbed residential door.
- 1980 Louis Vago purchases all the shares owned by his partner, Paul Kleinwachter. From 1981 to 1983, Vago serves as the president of NAGDM (National Association of Garage Door Manufacturers).
- 1984 The Americana, a raised-panel steel garage door, is announced.
- 1986 Vago sells controlling interest to Merchant Capital Group, an investment group, but he retains an interest and stays on as a consultant. The garage door division, previously a division of General Aluminum, begins operating as General American Door Company (GADCO).
- 1988 Joe Kee, an associate with Merchant Capital Group, becomes GADCO president. Previously, Kee had served with Rust-Oleum Corporation as Americas area director and with Abbott Laboratories in engineering, finance, and management. GADCO discontinues its aluminum siding operation to devote all resources to garage doors.
- 1990 General American Door introduces the Freedom Series garage door, the first raised-panel HDPE door.
- 1996 Joe Kee is elected to a two-year term as the first president of the newly formed DASMA.
- 1997 The firm drops its General Aluminum identity and officially becomes General American Door Company (GADCO).
- 2002 GADCO announces the Presidential Series of handcrafted wood carriage-house garage doors.
- 2004 GADCO introduces the Country Freedom Series 9004, an HDPE door in the carriage-house style.
- Today GADCO is a regional manufacturer serving the eastern half of the country, from North Dakota to Mississippi and all points east. Although most customers are installing dealers, the company still maintains a strong presence in the lumberyard market.

With a manufacturing plant in Montgomery, Ill., GADCO maintains distribution centers in Pendergrass and Valdosta, Ga., Bowling Green, Ky., Iron Mountain, Jackson, and Waters, Mich., Albany, N.Y., Twinsburg, Ohio, Allentown, Pa., Richmond, Va., and Poca, W.Va.
